Thank you for your interest in partnering with ISEE infynergy

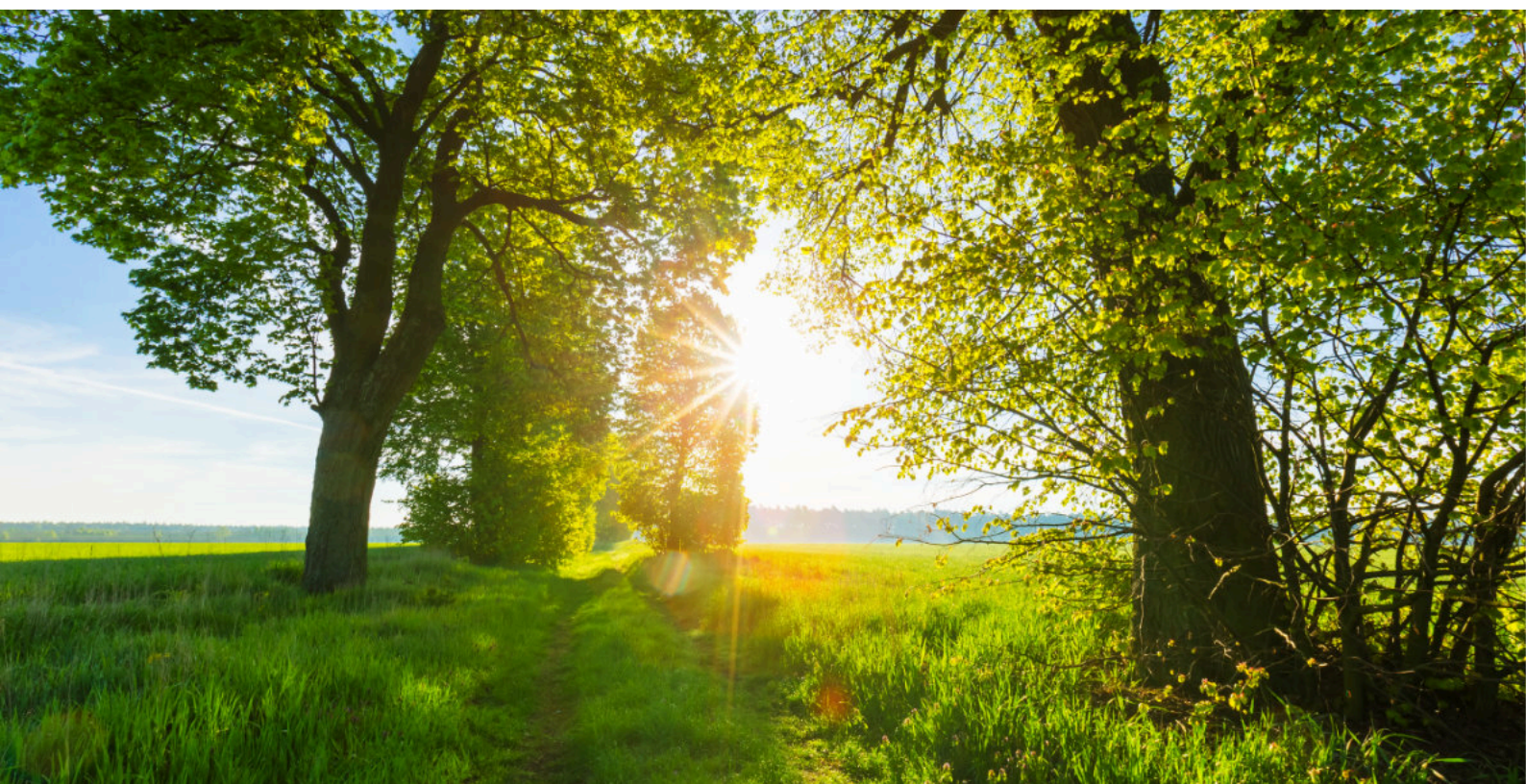
We are a heart centred movement devoted to creating breakthrough concepts and devices that are profoundly helpful to life and well-being.

Recommending Partner

The recommending partnership is a passive and hands free one. It is ideal for those that simply want to recommend the ISEE innovations, but do not want to provide any support or after sales care for the ISEE innovations and also do not want to be financially involved in the sale itself.

The features of this partnership are:

- ISEE infynergy will create a copy of the ISEE infynergy promotional video for you with your chosen promotion code. The promotion code gives 5% off to all your clients and friends who purchase.
- You can spread the promotional; video as far and wide as you like, such as via emails, websites, presentations etc., and we can even provide you with embedding code for you to integrate it into your existing website, if you have one. Please note that the promotional video cannot be copied or edited in any way due to the licensing of the material used.
- You do not need to send any ISEE innovations to your clients, we will supply and provide support for them on your behalf, including returns under warranty or any trial periods we offer.
- We will also provide you with the necessary ISEE innovation images for web development if you already have an existing website, or are planning to build one to promote the ISEE innovations. - You do not need to field any question or technical queries, unless you want to. We will handle all of that for you.
- You will receive a **5%** thank you commission for any orders that come through the main ISEE infynergy web-shop as well as a full itemised list of those who have made orders to date.
- You will receive your 'thank you' commission at the beginning of each yearly quarter. Please note that if any ISEE devices are still in any trial period we offer, on the date of commission payment, the commissions for those units will appear in the following quarter payment (if of course the purchaser chooses to keep them once the trial period expires).





Distributor Partner

The distributor partnership is more involved than the recommending partnership. It is ideal for those that want to be much more hands on and deal with clients directly. You might have a clinic, or a website and want to add the ISEE innovations to your product offerings etc.

The features of this partnership are:

- ISEE infynergy will create a copy of the ISEE infynergy promotional video for you with your chosen promotion code (if you would like one added, which is up to you). We can also add your specific website so that wherever the video is shared, those viewing will go to your website directly.
- You can spread the promotional; video as far and wide as you like, such as via emails, websites, presentations etc., and we can even provide you with embedding code for you to integrate it into your existing website, if you have one. Please note that the promotional video cannot be copied or edited in any way due to the licensing of the material used.
- You will provide both sales and support to your clients directly, but don't worry, we will help you with training and any questions that come your way that you don't yet have the understanding for (we view that this is a learning process and will support you through it while you get on your feet).
- You can choose to offer a trial period if you like, in which case, you will take care of any such returns and refunds as necessary.
- In case of any issues with warranty, such as a faulty device etc., that a client reports to you, we are able to test the condition of the device remotely and if found to be faulty, we will supply you directly with a replacement free of charge, unless there is a country partner in your country who will replace your unit(s) directly, and we will replace that stock for the country partner.
- Each distributor partner would be responsible for setting up their own 'terms of service' and 'returns and refunds' policies when selling direct to customers. You may of course copy and edit ours to suit your needs if you wish.
- We will also provide you with the necessary ISEE innovation images for web development if you already have an existing website, or are planning to build one to promote the ISEE innovations. - As a distributor, in understanding the extra energy needed, you will be able to purchase the ISEE innovations at a wholesale rate of:
 - ISEE Serenity - **525 USD** (Retail 788 USD), your profit = **263 USD**
 - ISEE Water - **315 USD** (Retail 473 USD), your profit = **158 USD**
 - ISEE Charge - **124 USD** (Retail 186 USD), your profit = **62 USD**
 - ISEE Vitality - **103 USD** (Retail 155 USD), your profit = **52 USD**
 - ISEE Motion - **110 USD** (Retail 165 USD), your profit = **55 USD**



Country Partner

The country partner can operate just as a distributor partner, and so the details of how you would provide direct to clients is the same.

However, as a country partner, you would be responsible to maintaining and holding stock, in proportion to being able to continuously supply the ISEE innovations directly to any distributors in your country/region. In the case of a large country, there can be more than one country partner. Each distributor that is there already, or any that come on board in the future, will be assigned to each country partner equally so that all country partners are supported in balance within that country.

And so as a country partner, you have a choice to:

- Provide ISEE innovations directly to the distributors in your country/region and retail in the way a distributor partner does
- Act as a distribution hub only, for the distributors in your country/region with no direct retail
- Act as a distribution hub mainly, for the distributors in your country/region, but also provide retail for the ISEE innovations as a distributor partner as and when it fits in with your lifestyle.

As a country partner you will receive a 'lower in value' wholesale rate to honour the additional involvement of supplying distributors.

Each country partner would be responsible for setting up their own 'terms of service' and 'returns and refunds' policies when selling direct to customers. You may of course copy and edit ours to suit your needs if you wish.

In terms of warranty in case of manufacturing fault, a country partner would supply a replacement if needed to either their customer directly or the distributor who supplied the unit(s), and we will replace those items directly to the country partner ourselves.

The only prerequisite we ask to become a country partner is that you develop yourself as a distributor partner first. This will allow you time to garner the knowledge and experience for the country partnership as you would also be supporting the distributors in your country/region with any questions they have.

As a country partner, you need to make sure you have enough stock to supply your distributor base continuously.



Frequently Asked Questions

- **If I'm a partner in one country can I sell in other countries?** Yes, provided that no other partner is operating in that country. We do ask our partners to work side by side with other partners in helping each other along, rather than with a competitive ethos. In that way we ask that you send any contacts you receive from other countries to existing partners in that country. Otherwise you are free to ship to that country.
- **Can I change from one partnership to the other if my circumstances change?** Yes of course you can. The partnerships we have a meant to be fluid to suit you r needs as well as to help these innovations get out to where they need to go.
- **How do I order devices as a partner?** If you're a recommending partner, you do not order at all, we handle the sales directly, you will have a promotional code that gives 5% off for your clients and they order directly from our website. If you are a distributor partner, we will invoice you for the amount of the ISEE innovations in the order you place, and will ship direct to you for resale to your clients.
- **What about import duties etc., can I add the cost of that on to my base price?** Yes you can, the fact that there are import duties in different countries is an unfortunate one, but we encourage that you do need to pass that on the the client as otherwise the burden on paying these yourself may make it too difficult to operate in flow. So in each case, as a **distributor partner**, we suggest adding the import percentage on the wholesale rate as that is the cost you are importing on. As a **recommending partner**, you do not need do anything with this other than advise your clients that they may have to pay import duties on receipt of their innovations.
- **Do I need to qualify for any of the partnerships?** No, you can jump straight in, however for the distributor/country partnership we ask that you purchase a full set of ISEE innovations, and the amount you would gain as profit for these will be returned to you as credit towards further devices as normal, as those additional devices are purchased. This is to ensure the partnerships are used in integrity as there is no other requirement to join. And so to avoid any potential misuse of otherwise easy to join in partnerships, this is the only condition we ask.
